Terms and Conditions Ski-Trip 2021

1. Definitions

Amsterdams Chemisch Dispuut (ACD): study association registered at the KvK with number: 40530501, btw-number: NL806634376B0; located at Science Park 904, 1098 XH, Amsterdam.

Vereniging Chemie Studenten aan de Vrije Universiteit (VCSVU): study association registered at the KvK with number: 40530099; btw-number: NL816602803B01; located at De Boelelaan 1083,1081 HV Amsterdam.

Wintersportcommissie: committee responsible for the organization of a ski-trip to Risoul in January/February of 2021.

Participant: a member or donor of the ACD or VCSVU who agreed to the Terms and Conditions via the Google Form 'Registration form ski-trip 2021 ACD x VCSVU' and has registered via the registration link from Husk. The committee will send a participant a (digital) confirmation.

2. General

The terms and conditions Wintersportcommissie 2020-2021 apply to every participant of the ski-trip for the duration of the trip, who have agreed to this and the only way to deviate from the Terms and Conditions is at least three board-members of ACD and three board-members the VCSVU agree with the deviation.

3. Costs

An indication for the costs of the ski-trip is €379,- and this amount can deviate with a maximum of €50,- depending on rental of ski-materials and the number of participants. Every participant is obligated to pay the amount to Husk before their payment deadline.

4. Service provided

For the amount ((+/- €379,-) the participant will be offered a ski-trip including:

- · Retour bus trip;
- · Accommodation in Risoul (2 nights);
- Food (breakfast and dinner, 2x);
- Ski rental (snowboard rental for higher costs, own material for reduced costs);
- Ski pass;

This offer applies only in the period of 28 January until 1 February 2021 and the participants are entitled to this when they adhere to the terms and conditions.

5. Accommodation

The participant is required to behave decently in the accommodation, when the participant is kicked out by the accommodation all costs are for their own account. The participant is also required to adhere to the terms and conditions and house rules of the accommodation.

6. During the ski-trip

Every participant must at all times:

- Carry a valid travel document;
- Carry no drugs whatsoever;
- · Follow the orders and requests of the committee;
- · Stay on the ski slopes;
- Stay together in groups 3 people minimum on the ski slopes;
- · Adhere to the corona-rules that apply during that time;

The committee and the ACD are not liable for accidents and are not responsible for the participants when they come into contact with justice.

7. Corona

The committee advises all the participants to have travel and/or cancellation insurance for this trip. In the case that the ski-trip is cancelled because of corona, the terms and conditions of the organiser Husk apply (100% of payed amount is refunded). The committee, ACD and the VCSVU are not liable or financially responsible in the case of cancellation.

8. Deposit

Each participant is required to pay a deposit for the trip. This money will be advanced by the ACD, under the condition that the ACD will get the whole deposit back. In the case that the deposit is not fully refunded to the ACD, the participant(s) responsible for the incident or the damage has/have to pay it back to the ACD. The committee, ACD and the VCSVU decide who is/are responsible for the damage or incident.

9. Final provision

When the participant does not adhere to the Terms and Conditions of the Ski trip 2021, he or she will be excluded from participating in the ski-trip and also excluded from participating in the next ski trip the committee will organise. The participant has to return home on their own account. One can only deviate from the Terms and Conditions when at least three board-members of the ACD and three board-members the VCSVU agree to this.
