

# Terms and Conditions BEC ACD 2021-2022

## 1. Definitions

Amsterdams Chemisch Dispuut (ACD): Study association registered at the 'Kamer van Koophandel' under number: 40530501; tax number: NL806634376B0 situated at Science Park 904, 1098 XH, Amsterdam

Foreign Exchange Committee (BEC): ACD committee responsible for organising the study trip to München in April and May 2022

Participant: A member or donor of the ACD that has enrolled themselves for 'BEC 2022 München' using the website 'acdweb.nl' and has received written confirmation of this enrollment from the BEC.

## 2. General

The terms and conditions BEC ACD 2021-2022 are applicable to each participant that has agreed to them. It is only possible to deviate from the terms and conditions if three or more ACD board members agree to this deviation.

## 3. Age

In order to take part in the study trip to München in April and May 2022, the participant has to be at least 18 years old on the first day of the trip.

## 4. Registration fee

The indicated fee for enrollment in the study trip to München in April and May 2022 is €200,-, this indicated fee can change with a maximum of €50,-. Once the deadline for free unenrollment has passed, every participant is obligated to pay the full registration fee. The definite registration fee will be determined and shared in writing to all participants at least fourteen days before the free de-enrollment deadline. Every participant is obligated to pay the registration fee to the ACD (NL45 INGB 0000 154 992, in the name of Amsterdams Chemisch Dispuut stating Inschrijfgeld BEC 2022 + first name + last name) before the payment deadline. The payment deadline will be determined and shared in writing at least fourteen days before the deadline. If a participant does not pay the full registration fee before the payment deadline, the participant will be placed at the bottom of the spare list.

## 5. Delivered services

For the required registration fee (+/- €200,- Euro), a participant will receive a study trip consisting of:

- Return bus or train (Amsterdam – München);
- Accommodation and breakfast in München (6 nights, breakfast 6 times);
- One end dinner;
- Access to each activity and excursion the BEC hosts with the exception of voluntary extra activities

This offer is valid from April 30 2022 up to and including May 6 2022. The participant is only entitled to this offer if the participant complies with the terms and conditions.

## **6. The bus- or train tour**

The participant must admit all of their necessary personal details for the bus- or train tour to the BEC before the deadline the BEC has set. The deadline will be determined and shared in writing at least ten days before the deadline.

## **7. Travel insurance**

ACD and BEC have no travel insurance. It is wise to take out travel insurance yourself.

## **8. Accommodation**

The participant is required to act decently in the accommodation, if the participant causes any damage or is evicted from the accommodation, the extra costs are paid by the concerned participant. The participant is also obligated to comply with the terms and conditions of the accommodation.

## **9. During the study trip**

Each participant should at all times:

- Carry a legitimate travel document;
- Not carry or use any drugs;
- Partake in activities labeled as compulsory in the BEC-magazine;
- Listen and comply with present BEC members.

The BEC and the ACD are not responsible for injuries and are not responsible for any participants when they come into contact with any legal issues.

## **10. Final provision**

When a participant does not comply with the Terms and Conditions BEC ACD 2021-2022, the participant will be excluded from the final dinner of the study trip and participation of any following study trips organised by the BEC. It is only possible to deviate from the terms and conditions if three or more ACD board members agree to this deviation.
